



## 2010 Chapter CI 101 Scholarship Program Information and Application

### Background

Through the Chapter Scholarship, the Education Foundation awards an \$845 voucher toward the cost of completing CI 101: Financial Analysis for Commercial Real Estate. The scholarship **must** be used within the calendar year of the award.

### Scholarship Value

\$845 voucher towards enrollment to CCIM Institute's CI 101 course - Financial Analysis for Commercial Real Estate. CI 101 is a required course for those pursuing the CCIM designation. Chapter scholarships are partial scholarships. While the Education Foundation of the CCIM Institute reduces the final cost for CI 101 Chapter Scholarship recipients, recipients are responsible for a \$295 course fee at the point of registration.

### How to Apply

The Chapter CI 101 Scholarship Application must be used to evaluate scholarship applicants. If the Foundation receives any applications from applicants directly, those applications will be forwarded to the Scholarship Chair/Foundation Liaison or President of your local chapter.

### Submission Deadline

Return completed application to the Scholarship Chair/Foundation Liaison or President of your local chapter by October 1, 2009. Notifications will be made to winning applicants by November 20, 2009.
